



Cisco Catalyst and DNA Advantage Use Right to ThousandEyes

Capitalized terms not defined in this document are as defined in the [Cisco General Terms](#) or similar terms existing between You and Cisco and the [ThousandEyes Offer Description](#) (collectively, the “**Agreement**”). Calculation of consumption of ThousandEyes Units can be found at [Calculating Units](#). “**Eligible Catalyst Purchase**” means the purchase of Cisco Catalyst 9300 or 9400 with a DNA Advantage subscription.

1. **Use Right Cap.** Your Use Right will be subject to one of the following caps:
 - a. **Current DNA Use Right Cap.** For each Eligible Catalyst Purchase licensed February 20, 2024 or later, You will automatically receive 22 ThousandEyes Units per month, up to a maximum of 11,000 ThousandEyes Units per month per Customer (the “**Current DNA Use Right Cap**”), subject to the restrictions stated in this Section 1 and Section 2 below. You may use these ThousandEyes Units for either Enterprise Agent or Cloud Agent Tests.
 - b. **Legacy DNA Use Right Cap.** For each Eligible Catalyst Purchase licensed prior to February 20, 2024 (a “**Legacy Order**” to a “**Legacy Customer**”), the chart below will be used to determine the maximum number of ThousandEyes Units per month You will receive, subject to the restrictions stated in this Section 1(b) and Section 2 below.

Applicable Cap	New Eligible Catalyst Purchase(s) made during the Use Term of the Legacy Order will be subject to the existing 110,000 ThousandEyes Units per month Use Right cap (the “ Legacy DNA Use Right Cap ”). For clarity, the Legacy DNA Use Right Cap remains in effect only until the expiration of the Use Term of the Legacy Order. If renewed, any renewed Eligible Catalyst Purchase will be subject to the Current DNA Use Right Cap.	New Eligible Catalyst Purchase(s) made during the Use Term of the Legacy Order will be subject to the Current DNA Use Right Cap
Access to Cloud Agents	You may continue to use ThousandEyes Units granted under this Use Right only for Enterprise Agent Tests (until renewal at which point the Current DNA Use Right Cap terms will apply).	You may use ThousandEyes Units granted under this Use Right for either Enterprise Agent or Cloud Agent Tests.

2. **Customer Organization Use Right Cap.** Under both the Current DNA Use Right Cap and the Legacy DNA Use Right Cap, all entities within Your Customer Organization (defined below) that purchased an Eligible Catalyst Purchase(s) are subject to a single maximum Use Right cap of 110,000 ThousandEyes Units per month (the “**Customer Organization Use Right Cap**”) regardless of the number of Eligible Catalyst Purchase(s) by Your Customer Organization. For clarity, no rights are granted under this Use Right to Affiliates who are not otherwise licensed to use the Eligible Catalyst Purchase(s). “**Customer Organization**” means You and Your Affiliates collectively.
3. **Examples of the Customer Organization Use Right Cap.** For example, if You are subject to the Current DNA Use Right Cap and two of Your Affiliates are also Eligible Catalyst Purchase(s) Use Right holders subject to the Legacy DNA Use Right Cap, then (i) You are subject to the Current DNA Use Right Cap on an individual basis, (ii) each of Your two Affiliates are subject to the Legacy DNA Use Right Cap on an individual basis, and (iii) Your three entities combined are subject to a single Customer Organization Use Right Cap. If renewed, each of the Affiliates subject to the Legacy DNA Use Right Cap will become subject to the Current DNA Use Right Cap.

If You are subject to the Current DNA Use Right Cap and ten of Your Affiliates are also Eligible Catalyst Purchase(s) Use Right holders subject to the Current DNA Use Right Cap, then (i) each of the eleven entities are subject to the Current DNA Use Right Cap (as applicable) on an individual basis and (ii) the eleven entities combined are subject to a single Customer Organization Use Right Cap.
4. **Legacy Billing Model.** You are ineligible to receive the ThousandEyes Units for your Eligible Catalyst Purchase(s) if any entity in Your Customer Organization is using the ThousandEyes’ legacy billing model.
